## Our Mission

To rescue dogs and cats from high kill shelters, primarily in Ohio, and to transport them to safe environments where they can be matched and evaluated with a new family. We also raise funds for veterinary care, transportation and food for rescued animals. Stop the Suffering provides resources to promote responsible pet ownership.



## Our Work

Too many of our rural companion pets die in our rural shelters because there are no places for them. These pets need help quickly including but not limited to:

- Care in shelter including food, de-worming, vaccines, flea and tick prevention
- Veterinary care both routine and urgent
- Temporary placement pending rescue
- Plan for spay/neuter
- Facilitating their release to a rescue group
- Transport to our own rescue or to over 100 pre-approved rescue groups

## Our Long Term Goals:

- Spay and neuter for all companion pets
- Decrease the number of homeless companion animals
- Assure rural shelter pets are treated with necessary care, and respect
- Fewer abandoned and feral animals
- Lower euthanasia rate at our rural shelters

- More advocates involved in animal welfare
- Children, the pet owners of tomorrow, learning about animal welfare and advocacy
- A great outcome for any companion animal leaving a rural shelter
